Early Years Pupil Premium & Pupil Premium Entitlement

All schools receive additional funding (known as early years pupil premium, or pupil premium) for pupils whose families are in receipt of the benefits below:

- Universal Credit with an earnings threshold that doesn't exceed £7,400
- Income Support
- Income Based Jobseekers Allowance
- Income Related Employment and Support Allowance
- Child Tax Credit, provided you **are not** entitled to Working Tax Credit and have an annual income, as assessed by HMRC that does not exceed £16,190
- Guaranteed Element of State Pension Credit
- Where a parent is entitled to Working Tax Credit run-on (the payment someone receives for a further four weeks after they stop qualifying for Working Tax Credit).
- Support under part VI of the Immigration and Asylum Act 1999.

If you are eligible for Pupil Premium, your child will be entitled to Free School Meals. However, if your child will be on packed lunches it is still worth applying for Pupil Premium, as we will still get extra funding for the school.

It is in **all** our interests that we bring in as much money as we can to support our school and ensure all of our children get the best possible education. To help your child and your school, we can do a very quick eligibility check for this additional funding via Durham County Council.

Please rest assured that the information you provide is confidential. If your child is entitled to receive the additional funding you will be informed by the School Office.
